WHAT THIS MEANS

- It has a capacity to process a minimum of two million passengers annually.
- Its billed to achieve HUB status for Nigeria in the West African Sub –region.
- The New Terminal will alter the ambience of the airport as new link roads have been constructed to create a drive and drop off arrangement for motorist plying the airport.
- The old Terminal would still be put to use because of constraints of size of the new facility.
- The New Terminal with strategically designed TRANSIT facilities will ease the stress of passengers and other users of the facility.
- The New Terminal is expected to have the latest Technology that is critical for check in counters, fibre optic technology to take care of all communication needs.

ECONOMY AND FINANCE

Continuation on The Finance Act Law 2020.

- ❖ Minimum tax payable by companies in respect of returns for years of assessments falling due between 1st Jan 2020 and 31st Dec 2021 has reduced from 0.5% to 0.25% of gross turnover less franked investment income..
- * Revenue collected from the new EMT levy will be shared based on derivation 15% to FG & FCT and 85% to State.
 - Public character for purpose of tax exemption requires an organisation or institution to be registered in accordance with relevant laws in Nigeria and must distribute or share its profits in any manner to members or promoters.
 - ❖ The scope of items liable to excise duties has been expanded to include Telecommunication services provided in Nigeria as may be prescribed in the law or an order issued by the President. You may have to pay more for airtime & data in the near future.
